I was present on April 6, at the National Assembly, when Corinne Payne, president of the Fédération des comités de parents du Québec (FCPQ), addressed the Committee on Culture and Education on the proposed school board reform Bill

On behalf of 62 parent committees, she told the MNAs that 80 per cent of parents generally approve of the provisions in Bill 86, which calls for parents, teachers, principals and support staff to have more decision-making power at their schools, aimed to benefit students.

This brings to mind the four polls taken by CTV News and Global Montreal, in 2015, on the matter of elected school boards. An average of the polls suggested that 68 per cent of the anglophone community want them ditched.

Madame Payne, told the Committee, the status quo is no longer acceptable because many parents are victims of "bullying and harrassment" when dealing with the boards. (*Le Soleil*, April 6)

The same point could be made on the English side.

In 2014, I ran for chairman of the Lester B. Pearson School Board. The Central Parents' Committee, wisely put out a questionnaire to all candidates running for commissioner. There was a special questionnaire for those running for chairman - the incumbent, Suanne Stein Day; the vice-chair, Angela Nolet, and me.

Question # 3, under the heading: "Vision and Leadership" was most telling: What will you do to reduce the intimidation and helplessness that many parents feel when they question the school board and its policies?"

Among the many interviews we did, I recall the vice-chair say on City TV on the 'Breakfast Television' show, on Oct. 20, 2014: "...we need a different type of leadership" ...and "...parents feel intimidated....

Her written answer included this sentence: "Firstly, the Chairman of the School Board should be approachable and non-judgemental."

Part of my written answer said: "Having been personally refused, along with others, the right to ask questions, and tossed out of Council, the Pearson board, to my knowledge, has been the only board that demands security be called, when the Chair does not like a question.

By far, the biggest complaint made by the French and English school board associations is that Bill 86 grants new powers to the Minister of Education. Madame Payne said the FCPQ considers this new power to the Minister a good thing . So

Presently, the system allows for abuse of power and a lot of school board secrecy. It is very hard for the parent, the taxpayer, the public to complain about matters, which include financial and ethical irregularities.

That said, in an unexpected turn of events, La Presse reported on April 9, that Premier Couillard is reconsidering the idea of scrapping school board elections. He said one reason is the English school boards have brandished the threat of a

Throughout the day, CJAD reported the reaction of the news by the chairpersons of the Lester B. Pearson School Board and the English Montreal School Board. Suanne Stein Day expressed she was "beyond delighted;" Angela Mancini announced the move was a "victory for the anglophone community."

This is no victory. This is a loss for democracy, accountability and openness. Schools matter! Parents rule! Mr. Couillard: Bill 86 is good!
